Claud Morris Edwards, 83, of Huntsville, Arkansas, died April 4, 2009 at his home. He was born June 14, 1925 at Red Star, Arkansas, the son of William Demps and Lissie Belle Hodge Edwards. He was a retired safety consultant for the Arkansas Department of Labor and a veteran of World War Two, serving in the United States Army.
