Curtis Carson Glenn, Jr., 69, of Asher, Arkansas, died June 3, 2013 at his home. He was born September 15, 1943 at Prairie Grove, Arkansas, the son of Curtis Carson Glenn, Sr. and Alta Euthema Tackett Glenn. He was a 1961 graduate of Saint Paul High School, a carpenter, a dairy and beef cattle farmer and founded Glenn's Bulldozing in 1985.
