



## Nathan Lee Gaskill

July 26, 1919 - June 28, 2009

Nathan Lee Gaskill, 89, of Huntsville, Arkansas died June 28, 2009 at his home. He was born July 26, 1919 at Huntsville, Arkansas the son of Walter Lee and Cinda Brown Gaskill. He was a veteran of World War Two serving in the United States Army and had been a member of American Legion Hayes-Smith Post 137 for 65 years. He was a member of the Huntsville Church of Christ and a founding member of the Huntsville Volunteer Fire Department, serving for over twenty-two years. He was employed at the First National Bank in Huntsville from 1946 to 1951. In 1951 he began work as the parts man for Mowery-Whitson Ford in Huntsville and in 1957 he purchased Mr. Whitson's half of the business and retired as a Ford dealer in 1988. He was preceded in death by his wife of fifty-eight years, Alice Fanning Gaskill on January 16, 2005 and two half-sisters, Effie Pearl Gaskill and Nettie May Gaskill.
