Steven Dwan Treat, 57, of Huntsville, Arkansas, died August 22, 2009 at the Northwest Medical Center-Springdale. He was born October 19, 1951 at Eureka Springs, the son of Sheriff Dwan W. and Virginia Lee Begley Treat.
